- D. Standard ILC Dover Purchase Order terms and conditions (available at www.ilcdover.com under the "Suppliers" link).
- E. Statement of Work

2. NFS CLAUSES

Goods or services provided in fulfillment of this order are chargeable to a contract issued by an agency of the U.S. Government, the NASA. The NASA FAR Supplement (NFS) clauses cited below, in effect as of the date of the accompanying Purchase Order, are incorporated by reference with the same force and effect as if provided in full text.

As used in the NFS clauses cited below or as otherwise incorporated herein, clauses are subject to the following alterations:

- A "Contractor" shall mean Seller
- B. "Contract" or "Schedule" shall mean Buyer's Purchase Order
- C. "Government", "Department", "Secretary", "Contracting Officer", "Controller General" and any other term of similar import shall mean Buyer.

Any other change required for Buyer to have with respect to Seller the same rights that the Government would have with respect to Buyer under any of the cited NFS clauses should they appear in a Government contract with Buyer shall also be deemed to have been made.
